



Support Federal Anti-Scab Legislation, Support Bill C-257!

The vote is on October 18th and we are asking you to call/write your MP and tell them you are supporting the Local Labour Council's request to lobby MPs to support Bill 257, the Bill Banning Strike Breakers, stress the importance of it and tell them you will be watching the results of the 2nd reading. The CLC and Local Labour Councils have met with most of the Nova Scotia MPs.

Following is a list of Nova Scotia MP's, with information about how they voted the last time on Anti-Scab, and what they've said they'll do this time.

Scott Brison, MP King's - Hants(Liberal) - Constituency office (902)542-4010 . Scott Brison voted against the legislation last time. Was very interested in hearing what we had to say in our meeting and indicated that he would give this issue serious consideration this time.

Bill Casey, MP Cumberland - Colchester - Musquodoboit Valley (Conservative Party). Constituency office: 902-893-2455 (Truro); 902-667-8679 (Amherst) Mr. Casey voted against the legislation last time. He would not make any commitment to support it this time either.

Rodger Cuzner, MP Cape Breton - Canso (Liberal) Constituency Office: 902-842-9763 Mr. Cuzner was absent from the first vote. When we met with him, he told us he missed the vote because he really didn't know what to do on this issue. Since that time, he has spoken with many people, and is firmly committed to support Anti-Scab legislation this time around.

Hon. Mark Eyking, MP Sydney-Victoria (Liberal) Constituency office: 902-567-6275

Mr. Eyking voted in favour of this legislation last time. He is committed to vote in favour again this time.

Gerald Keddy, MP South Shore - St. Margaret's (Conservative)

Mr. Keddy voted against the legislation last time. Seemed to be giving serious consideration to supporting it this time, but would not make any commitment on that.

Hon. Peter MacKay, MP Central Nova (Conservative)

Mr. MacKay voted against the legislation last time. We have not been able to get a meeting with him to discuss this issue this year.

Alexa McDonough, MP Halifax (NDP) Constituency office: 902-426-8691 Ms. McDonough voted in favour of the legislation last time. She will support it again this time.

Hon. Geoff Regan, MP Halifax West (Liberal) Constituency office: 902-426-2217 Mr. Regan voted against the legislation last time. He would not make any commitment to support the legislation this time, but said he would raise it in the Liberal caucus.

Michael Savage, MP Dartmouth - Cole Harbour (Liberal)

Constituency office: 902-462-6453. Mr. Savage voted in favour of the legislation last time. He will support it again this time.

Peter Stoffer, MP Sackville - Eastern Shore (NDP)

Constituency office: 902-865-2311. Mr. Stoffer voted in favour of the legislation last time. He will support it again this time.

Mr. Thibault voted against the legislation last time. We have not yet met with him to talk about this time.
